## 2020 RANGE SAFETY RULES



- 01. <u>Controlled Substances</u>: No one is allowed on the range under the influence of alcohol or any other controlled substance including prescription medication.
- 02. <u>Shooting Alone:</u> Each shooter must be accompanied by another shooter or observer. Only active and / or retired Law Enforcement Officers, those with a Firearm's ID Card, or BYOG Range Members may shoot alone.
- 03. Rental Age: To rent a Handgun or Long Gun a customer must be 18 years of age.
- 04. <u>Shooting Age</u>: No one under the age of 10 may be allowed to shoot any firearm in the facility. Minors may shoot only with the consent of a legal guardian who completes this registration form on their behalf. Subject to our discretion.
- 05. <u>Carrying of Guns and Ammunition</u>: No loaded firearms may enter or exit the building. Loaded firearms allowed at firing line only. Exceptions are only for active Law Enforcement.
- 06. <u>Inspection of Guns and Ammunition</u>: All personal guns and ammuntion are subject to inspection by Long Shot Staff. All guns or ammunition found to be unsafe or unserviceable will not be allowed into the range.
- 07. <u>Maximum shooters</u>: Maximum of two shooters are allowed per lane.
- 08. Eye and ear protection: Must be worn at ALL TIMES on the range.
- 09. <u>Allowable Targets</u>: Only Long Shot paper targets are permitted on the range. Unauthorized targets not permitted.
- 10. <u>Holsters</u>: Wearing or drawing from a holster is only permitted for law enforcement, active military and Long Shot approved civilians who have successfully completed our Holster Drawing class or Long Shot qualification.
- 11. Gun Handling rules:

- a. Always keep your gun pointed down range
- b. Always keep your finger off the trigger until ready to fire
- c. Always keep action open and firearm unloaded until ready to shoot
- d. Be sure gun is safe to operate prior to discharging.
- e. Use only correct ammunition for your specific gun
- f. Unload, open the action, remove the magazine and bench all firearms during a cease-fire
- g. To leave the firing line temporarily or pass gun to another shooter, table your unloaded firearm with the action open and the muzzle pointing downrange.
- 12. All firearms must arrive and leave the range in a case. No uncased firearms may leave the shooting area.
- 13.If any misfire or malfunction occurs, place firearm on bench pointed downrange, signal Staff and wait for assistance. DO NOT leave the firing line with a loaded or jammed firearm.
- 14. Allowable calibers for handguns and long guns will be posted and must be strictly followed.
- 15. ABSOLUTELY NO STEEL CORE AMMUNITION OR TRACER AMMUNITION IS ALLOWED!! SHOTGUNS MUST BE FIRED FROM THE SHOULDER ONLY. NO STEEL OR BIRD SHOT IS ALLOWED. SHOTGUNS WITH PISTOL GRIPS ARE NOT ALLOWED.
- 16. No fast or rapid firing allowed. Allow at least one full second between shots. ANY BEHAVIOR DEEMED HAZARDOUS BY LONG SHOT STAFF MAY RESULT IN IMMEDIATE DISMISSAL FROM THE PREMISES.
- 17. Comply with all instructions from the range staff. Report any unsafe conduct to the range staff immediately.
- 18. Any violation of Safety Rules will result in REPRIMAND UP TO AND INCLUDING DISMISSAL from the range.
- 19. Only ammunition purchased at Long Shot will be allowed for rental firearms.
- 20. LONG SHOT STAFF AND / OR RANGE SAFETY OFFICERS (RSO'S) HAVE ULTIMATE AUTHORITY TO ENSURE CUSTOMER SAFETY INCLUDING ISSUING IMPROMPTU SAFETY DIRECTIVES TO ALL SHOOTERS.

# ADULT RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of being allowed to enter the premises of Long Shot Pistol and Rifle, LLC ("Long Shot") located at 375 County Avenue, Suite 1, Secaucus, NJ 07094 and / or use the facilities including but not limited to the gun range therein ("Facilities") and / or participate in any of the activities including but not limited to those of the gun range, I hereby agree to each of the following terms and conditions of this Agreement, and I have initialed each as having been read and understood by me:

01. I have read Long Shot's Range Safety Rules, a copy of which has been given to me by Long Shot. I understand these Range Rules may be amended from time to time and that I am responsible for reviewing the posted Range Rules when I use the Facilities. I affirm that, before using the Facilities, I will have partiipated in Long Shot's safety briefing not limited to watching the safety video and meeting with an RSO to review operation of my fire arm. I agree to comply with Long Shot's Range Safety Rules. INITIALS

02. I am responsible for becoming familiar with and understanding the operation of each firearm (hand gun or long gun) which I will use at Facilities. The word "operation" includes the safe handling, loading and unloading procedures, and the safety mechanisms and features of each firearm. INITIALS \_\_\_\_\_

03. I understand that Long Shot requires only newly manufactured commercial ammunition on the range, and that the use by me or those in my group of reloads or handloads is not allowed. I accept full and complete responsibility for the inherent risks resulting from my, and anyone else in my group's, use of reloads or handloads, including all responsibility for personal injuries to myself, other's in my group and others on the range. I also agree to thoroughly check to be sure I am using the correct ammunition at all times. INITIALS

04. I agree that prior to participating in or observing any shooting activities, I will inspect the Facilities, firearms and ammunition to be used and, if I believe anything is unsafe for any reason, I will so advise Long Shot Staff and/or an RSO. I will turn over to Long Shot any firearms and ammunition which I believe to be unsafe or noncompliant. I will also immediately leave any portion of the Facilities I believe unsafe. INITIALS

05. I fully understand and accept that I and all others engaged in shooting, coaching, observing or training with firearms at Long Shot have willingly engaged in activities that involve inherent risks of serious personal injury including disability or death and severe social and economic losses which might result from my actions or inactions or the actions or inactions of others, and futhermore, that such risks may be increased by factors not limited to: 

b. the failure of others to do the same:

- c. the characteristics, including the design, manufacturing or other defects, of any INITIALS firearm or ammunition being used by myself or others at Long Shot; INITIALS \_\_\_\_
- d. the characteristics, including the design, construction, and maintenance, of Long Shot's Facilities including, but not limited to, the multiple ranges; and
- e. the inability of Long Shot staff (including Range Safety Officers) to, at all times, monitor or supervise all Long Shot members, customers, guests, and others using INITIALS Long Shot's Facilities including but not limited to the ranges.

06. I accept full responsibility for any damage or destruction I cause to Long Shot property, whether accidental, negligent, willful or otherwise. Long Shot property includes, but is not limited to, the parking lot, the building structures and installations, the Facilities and range equipment. I grant Long Shot the right to recover from me a reasonable charge for any such damage and the recovery of its costs, including reasonable attorney fees, incurred in bringing any claim for such damage. 07. On behalf of myself, my heirs, executors, administrators, successors and assigns, I hereby waive, discharge and covenant not to sue Long Shot, its Landlord, their affiliates, and each of their officers, directors, owners (members), managers, employees, and agents, deeming and recognizing them as released parties ("Released Parties") from any and all liabilities, claims, demands, actions or lawsuits whatsoever seeking damages on

account of any personal loss or injury, disability, or death occurring to myself or anyone else, caused in whole or in part or alleged to be so caused by the actions, failure to act, or negligence of any of the Released Parties or caused by anyone else.

08. On behalf of myself, my heirs, executors, administrators, successors and assigns, I hereby assume all risk of personal injury, disability, damages and / or death. The word "damages" includes, but is not limited to, the incurring of physical and emotional injury of any kind, loss of physical function, ability or capacity, medical expenses, lost wages or income, loss of consortium and any other compensatory damage.

09. On behalf of myself, my heirs, executors, administrators, successors and assigns, I hereby agree to indemnify and defend the Released Parties from any and all liabilities claims, demands, actions or lawsuits whatsoever seeking damages on account of any personal loss or injury, disability, or death occurring to myself or anyone else, caused in whole or in part or alleged to be so caused by the actions, failure to act, or negligence of myself, my guests or minors for whom I am responsible. INITIALS

10. I agree that this Adult Release, Assumption of Risk and Indemnity Agreement shall be interpreted according to New Jersey law and that any dispute shall be resolved exclusively in the federal or state courts located in the State of New Jersey.

INITIALS 11. Access to, use of the Facilities of, Membership in Long Shot will be available to persons who may legally possess a firearm. Long Shot customers, guests, visitors and Members must be in compliance at all times with all federal, state and local laws and regulations concerning ownership, possession and handling of firearms. Access to, usage of the Facilities of, and Membership in are granted, and may be revoked, at Long Shot's sole discretion. INITIALS

12. In the event I bring a minor to Long Shot, the attached Adult Release, Assumption of Risk and Indemnity Agreement must have been signed by the minor's legal guardian. INITIALS

13. I recognize that my safety and the safety of everyone at Long Shot is my responsibility and I agree not to cause harm to myself or others at Long Shot.

I recognize that if I do anything while using the Facilities (including in any of the parking areas of the Facility) to intentionally cause, in any way, personal injury (including death) to myself or that may intentionally or negligently cause personal injury (including death) to any third party or cause damage to property owned by any third party (including Long Shot and / or its Landlord), Long Shot shall have the right to bring a claim against me and / or my heirs, executors, administrators and assigns to recover damage cause both to any property of Long Shot and its Landlord and to the business of Long Shot and its Landlord as a result of such acts. INITIALS
